- ED-204A / DO-356A
 - Consultations was opened from Dec 2019 to 1 Feb and all the comments received were posted
 - All comments reviewed by order of priority NC and H
 - For M & L there will be a submission A final webex will be launched for final resolution of comments with mandatory written proposition of counter proposition
 - So how and when will people see what the full document looks like with all the comments in situ
 - You will have a clean version and a changed tracked version and the comment spreadsheet. Dave Pierce believe it will be two to four weeks but this needs to be confirmed
 - SS Do we believe we can do this in one webex, as long as not too many disagreements – Yes
 - o CR Can we have a timeframe
 - FD Yes and final NC and high in two weeks and at the same sort of period the Med and Low so we can start to review then, and have a webex after that. SO one month the changes for the new document then down to the editor to incorporate and include
 - CR If there is no written resolution what is the proposal, each leader has commented on the comments and the leaders of the comments will handle this including rejection of comments
 - o PM- will you write whether comments are rejected
 - o FD Yes
 - o KH When to you expect to be complete for resolution
 - FD Two months and still aiming for approval for the June Plenary

- Way Forward ED204A/DO-255A and ED-XXX/DO-ISEM
 - o ED204A Have document ready for approval in June
 - ED-XXX Need to finalise the table of contents, There is a need for more contributors but the plan is to have another document ready for June

Comments and questions

- FD question for Cyrille
 - How is the relationship to be developed with the other working groups, and it is proposed that there will be a dedicated quarterly meeting to coordinate
- CR I am starting to make contacts with the other groups and there is also the ESCSG group which has a list of standards around information security
- SS The next ECSCG meeting is in June and that will give an overview of the standards they are tracking
- PW and LL Raised to working groups ED 117 and WG-108 and also whether there is an RTCA equivalent
- o KH Most don't have an RTCA equivalent
- BH What happens if the plenary meeting in June cannot be face to face, will be another webex meeting and if not face to face do we lose the risk of losing content
- DP Always a risk you would lose content, we have to do our best in the timescales and the current circumstances
- SS Made a request for more hours if we go Virtual webex for the next meeting due to the inefficiency of the webex process
- DP The meeting scheduled in June is going to be all five days so people should not leave early
- CR Whilst the use of webex is suboptimal he appreciates the contributions made this week
- CH What date do you need the ED201A document
- CR For ED201A and as a result of the tabletop, whilst the feedback was interesting there is a need for more representative organisations. So more time should be given to work on ED201A and we should organise another Table top, with a more representative case study and attendees so that the guidance material can be tested again
- o DP what participation support is their from RTCA for ED201A
- CR -We are lacking Airlines and Airport participation and would be good to have SC-216 contribution
- SS Tabletop exercise was primarily a European exercise due to Part AISS
- o CH Many of us have operations at Europe, too
- SS Next tabletop can try to accommodate other timezones and it will depend on whether if it is virtual or physical

 CR Proposes to move the ED201A Open Consultation to September and publish in March 2021, this will mean a change in the TOR

SG4 Report - Led by Stefan Schwindt

- ED-201A / DO-???
- We have had the validation exercise and we now need to engage with the existing section leads to update the sections and see if the existing schedule can be maintained
- CG If the sections slip a month could have an issue with the table top in a month
- SS May need to postpone table to a month and a half
- SS SS/AB to take an action to talk to the section leads about the revised schedule and agree way forward
- SS The use case to be used in the Table top will need to take into account all the organisations we need
- SS When will the next ECSP meeting take place
- CR no information to date (updated post meeting: the ESCP meeting planned 31/03 to 2/04 was cancelled because of COVID-19 and no date has been yet definitively decided for the next rendezvous but it is expected to have it organised via teleconference during the second half of April.)
- SS This needs to be known as we need to align with the ECSP
- SS If there is a schedule slip there is an opportunity to now take into account ISMS or have a translation table for the maturity tables

EUROCAE SGs and RTCA Harmonisation

- Scope and EU-PART AISS
 - CR gave an overview of the European context of Part AISS which includes organisations and the standards we are working in today, and in particular ED201A which is expected to form part of the guidance
 - Note for harmonisation ED205 as RTCA don't have that equivalent document so we need to take that into account
- Glossary status
 - Update on EUROCAE ER-13 (Clive)
 - CG Document has been updated to reflect the published joint documents
 - DP Any concerning about releasing the document
 - No concerns so we can proceed to publish
 - The document will be updated as each new EUROCAE document is published with the latest definitions
 - The decision to publish was put to vote by the attendees there were no objections to publication and the consensus was to publish the document
 - The vote was done using the "rise hand" tool and managed by the host of the webex at that moment, Dave Pierce. Two questions were asked, first if there is any opposition to publish (no hands for opposition), second, who agrees to publish (26 hands yes, 6 abstain).
 - RTCA sc-216 new glossary document status
 - KH This has been raised a number of times but as yet has not received a satisfactory answer, they are still looking for a solution that does not need to go through FRAC
- Document schedules: are we still on track?
 - DP Comment on the schedules he believes we are still on track
 - CR Documents should be on track ED201A will be challenging
