3. Approval of Meeting #6 Minutes

4. Updates about joint activity WG115-SC238

JM updates about the joint activity WG115-SC238:

- At the beginning of October 2020, a Call for Participation was launched to inform and get involved new parties interested in WG-115/SC-238 activities. As result of this:
 - New EUROCAE and RTCA members have joined the WG/SC.
 - One (1) application for the editor position was received.
 - JM introduce Juan Vicente Balbastre as new editor for the SPR/INTEROP stage (see slide 33).
 - JM and Ryan Wallace [RW] thank the Juan's step forward, his role will be really valuable during the new stage.
- A Technical Meeting focused on SPR and INTEROP took place the 10th of November 2020.

5. Updates from Partners

JM updates about some related organisations such as:

DG HOME

- Counter-UAS innovation workshop (link Community of Users for Security, Safe and Resilient Societies (CoU)) (10th November 2020)
 - The focus of the workshop, which will be organized around discussions of specific scenarios, is on innovation and thus for projects to demonstrate, how their specific solutions could fit into existing counter-UAS strategies.
 - Participation some WG-115 members and U.S. DHS S&T representatives.

NATO

- C-UAS WG Technical Standardization Sub-group Meeting (25th September 2020, 16th October 2020)
 - Next meeting: 20th November 2020
- Initial Planning Conference (IPC) of a NATO Counter Unmanned Aerial Systems (C-UAS) Technical Interoperability Exercise (TIE) (9th 10th December 2020)
- o Drone SLAP (Single Local Air Picture) (6th October 2020)

EUROCONTROL-SESAR-FAA (TIM)

- Participation in the Technical interchange meeting (TIM) on unmanned aerial systems and urban air mobility (13th November 2020)
 - The goal of the meeting is to exchange know-how and research results and encourage collaboration and harmonization of aviation research in the area of UAS and UAM.
 - Presentation about "Industry Standards in Support of ATM/UTM/C-UAS integration"

Some questions during the plenary meeting:

- Regarding the TIM session, AV asks if JM has received any feedback. JM answers he received
 only some questions during the TIM session. In next days, the presentations and (probably) the
 videos of the TIM sessions will be published, maybe then some additional questions/inputs are
 received.
- RW asks if it is possible to have access to the meeting minutes of the OTAN Technical Standardization Sub-group. AV and JM answer that not directly, that is why every plenary meeting the leadership team share information about the activity of these group.

6. Review of OSED OC/FRAC

JM presents a summary of the comments received during the OC/FRAC period:

JM introduces the next steps to be followed, see slide 21, main steps:

- All comments received are transferred to the WG for consideration.
- Chapter Leaders will prepare an early comment review and resolution.

- Arrange comment resolution meeting for reviewing the comments and achieve consensus.
- Upon completion of the comment resolution, the WG shall state that they have achieved consensus on the final draft; this must be properly recorded.
- The WG sends the final draft, together with the complete Comment Response Document, to the TPM.

7. SPR/INTEROP

- Taking into account not all participants in the plenary meeting joined the technical meeting focused on SPR/INTEROP which took place the previous week (10th November 2020), JM shares the agenda of that session and the main resulting actions (See slide 23). Main actions:
 - Get involved more airports and ANSPs representatives.
 - Creation of a first approach of the new working teams A Questionnaire was defined and shared with the WG/SC members in order to gather their experience and interests related to SPR/INTEROP as well as what challenges each member identifies.
 - Organize a focus session where airport representatives and other experts can share their C-UAS experience with the WG/SC members, including information about the state of e-Identification.
 - This action includes to Identify a candidate date for this session.
- In order to get all participants aligned with the current status of the joint activity. JM shares with the WG/SC a status update, highlighting the importance of the TOR (Terms of Reference) and explaining the established objectives for the SPR and INTEROP documents, including specific remarks which clarify the scope (slides 25 to 30).
- JM and RW focus on the creation of the editorial teams for the next stage, considering 4 teams:
 - Global approach team: the teams will consider topics such as the general functional architecture, overall C-UAS timeline, allocation of operational requirements included in the OSED.
 - Performance team
 - Safety team
 - **INTEROP** team
 - Note: The interaction among the team is crucial.
 - Note1: JM highlights the less active contributors are involved, the more challenging the established objectives and schedule will become.

After an intensive activity, the editorial teams are created, see below:



- Some comments about these teams:
 - The teams have been created based on the primary preference of each WG/SC member. Each team is open to any member beyond primary preference.
 - o In order to ease the team management, the leadership team considered a priority to identify two co-leaders per team.
 - The rest of WG/SC members interested in participate actively, please, contact with some member of the leadership team (JM, RW, AV, AS) and specify your primary preference.
- After three intensive hours of plenary meeting, JM and RW proposes not to enter in the brainstorming (next item of the agenda). The brainstorming questions will be shared with the team co-leaders to be considered as starting material (See slides 37 and 38).
- Finally, JM share a provisional approach for the next weeks (planning), considering:
 - Comment Resolution meeting for OSED
 - To be proposed after previous review of received comments by chapter leaders of the OSED.
 - Next focus session (SPR/INTEROP)
 - December (To be confirmed ASAP)
 - Each editorial team is required to (1) develop a list of questions for the presenters in that session, (2) provide first approach for their team activity.
 - Next plenary meeting
 - End of January 2021 (To be confirmed ASAP)

8. AOB

- As pending question, JM and RW will ask RTCA (Al Secen (AS) and KH) if any candidature for the vacancy of SC-238 Secretary has been received.
 - Reminder from previous plenary meeting: AS explains the importance of this role, in charge of different tasks including: draft the calling notices for WG meeting and submit them to the Technical Programme Manager (TPM), draft the minutes of the WG meeting and submit them to the TPM, manage the workspace by uploading and managing documents, manage the list of meeting participants and ensure registration procedures are respected, etc. Additionally, AS highlights this role is not time demanding.
