The twenty third meeting of RTCA Special Committee 209 was held on October 21st, 2021 via Webex/Telcon. The Plenary was held jointly with WG-49, with representatives from both RTCA and EUROCAE present. This meeting was held in order to gain Committee approval for starting the Final Review and Comment (FRAC) / Open Consultation (OC) period for the Change 1 to the RTCA DO-181F / EUROCAE ED-73F MOPS. This meeting was held immediately following the SC-186 Plenary which included on its agenda a similar action for the Change 1 to the ADS-B 1090ES MOPS. The CSC is a joint RTCA / EUROCAE effort, composed of four committees: RTCA SC-209 WG-1, EUROCAE WG-49, RTCA SC-186 WG-3, and EUROCAE WG-51 SG-1.

1. Introduction and Welcome for SC-209 and WG-49

The meeting was called to order by SC-209 Co-Chair Thomas Pagano of the Regulus Group at 11:04 AM (EDT) on October 21st, 2021. Mr. Pagano began the meeting with a welcome to all participants and then turned the meeting over to Al Secen of the RTCA for a policy review.

Al Secen welcomed all attendees to the Plenary and then he and Alex Engel covered the membership policy and both the anti-trust and propriety information policies for RTCA and EUROCAE. Additional information was provided as to the unique circumstances that precluded the Plenary meeting from being held in person.

Introductory statements concluded with EUROCAE WG-49 Chair Eric Potier and SC-209 Co-Chair Matt Erickson providing their welcoming remarks.

2. Review of Agenda

The agenda was reviewed and the floor was open to any changes or modifications to the proposed schedule. Eric Potier informed the Committee that bullet 6 of the agenda – for the approval of DO-181F to enter FRAC – also covered the approval of ED-73F to enter Open Consultation. Tom Pagano concurred, noting that this was a joint Plenary with EUROCAE for Change 1 to both DO-181F and ED-73F to enter the review period.

3. Review of Minutes from the 22nd Meeting of SC-209

Tom Pagano and Al Secen confirmed to the Committee that the Minutes from Meeting 21 of SC-209 had been posted to the RTCA Workspace. The floor was opened for comments and/or corrections to the Minutes. With no comments received, the Minutes were accepted as posted.

4. Status Brief

Tom Pagano presented the Co-Chair status briefing on the activity of SC-209. Following a review of the joint RTCA / EUROCAE work on developing the requirements documents, a summary of the issues addressed in the Change 1 document was discussed. The primary motivator for the Change 1 to the Transponder MOPS being revisions to reduce the number of registers serviced by the Basic Dataflash application. Additional corrections were also noted as being addressed in the Change 1 document. These include corrections to pulse tolerance specifications, test procedure corrections and additions, and a number of editorial fixes. Mr. Pagano then reviewed the remaining timeline and schedule to completion of the Change 1 document. The FRAC / OC period, upon approval by the Committee, was identified as running from the 26th of October until the 10th of December. Following the completion of the final review period, comments would be resolved during a two day meeting on the 15th and 16th of December, with Plenary approval of the final documents scheduled for December 17th. The review concluded with an official request to enter FRAC / OC. Matt Erickson motioned to approve entering FRAC / OC and Matt Haskin seconded. The floor was then handed to Eric Potier and Alex Engel who concurred with the approval and noted no objections were received from the EUROCAE side.

The format of the Change 1 documents were reviewed following approvals to enter FRAC / OC. The documents were to use line numbering with gray highlighting for new text and red strikethrough for removed text. The procedure for the FRAC / OC were also covered, noting that that this would only be a review of the Change 1 content and not of the documents as a whole. Al Secen followed this with a detailed review of the RTCA comment review and submittal process.
